



Hidden Hills Ranch Rules

Open 7 AM to 7 PM

(Except due to Veterinarian Medical Emergency)

General Rules

- *Immediately upon entering the Stable premises, all visitors must sign a liability release in the form provided by Stable; no exceptions.
- *No dogs, without prior permission and arrangements. Dogs are permitted on Stable property so long as they are under their owner's control at all times.
- *Dogs are not permitted in the horse working areas: barns, arenas, round pens, cross ties, wash racks and under no circumstances may dogs be permitted to chase other animals on Stable premises. Stable may, in its discretion, refuse to permit a particular dog to return to the Stable property.
- *Dogs must be on leashes at all times; Dog owners will be held responsible for the actions of their dogs, including damages and liability.
- *Dress appropriately (pants, t-shirt, boots)
- *Medical releases for Authorization to treat minors should be filled out for all riders under 18 years of age left at HHR without a parent or legal guardian
- *Children under 10 must be accompanied by a parent or a guardian at all times
- *Small children must be in hand at all times. Under no circumstances may boarders or their guests allow children to yell, run or otherwise spook or antagonize horses or annoy other boarders.
- *No baby strollers, bicycles, motorized vehicles or toys likely to spook horses are permitted on Stable premises.
- *No running or screaming
- *Balloons, firecrackers and other potentially noise-making items are prohibited.
- *No guests may ride/handle horses without prior permission from HHR Owners
- *Prior to leasing a horse, the boarder must obtain prior permission from Stable management.
- *Be kind and respectful to others
- *No smoking permitted on Ranch property
- *No vulgar language
- *No drug or alcohol use - anywhere, anytime!
- *No glass bottles
- *No one is allowed to use the stable equipment (tractor, gator)
- *Do not climb on fences
- *Residence on property is private, we ask that you respect our privacy and do not enter unless invited
- *Be aware of the dangers of the presence of rattlesnakes.

Safety Rules

- *Helmets required for minors under the age of 18, during all riding periods
- *Helmet use for Adults is optional; suggested and strongly encouraged but not required. However, ride/handle horses

- *Riding or handling a horse under the influence of drugs or alcohol is strictly prohibited on the ranch premises.
- *No jumping

Barn Rules

- *The Stable has a zero tolerance policy for abuse of any animals or person.
- *Clean cross ties after you use them and dispose of all trash properly
- *No turn outs in the arena's
- *Longeing in the riding arena(s) is permitted only when others are not riding.
- *Turn outs are only permitted in areas designated by Stable: in bull pens and pastures only.
- *Turn outs shall not exceed 30 minutes per horse.
- *Do not leave your horses in bull pens or pastures for unattended turn outs. You **MUST** put your horse back in his/her stall
- *No changing stalls without permission
- *HHR has the discretion to change your horses stall due to horses fighting over fence line or damage to his/her stall
- *NEVER tie horses to other stalls, fencing of any kind or structures. Use tie poles and hitching posts.
- *Pick up your trash. Do not litter.
- *No clutter or storage of items in barn isles. Storage of loose articles, materials, tools etc... are to be stored/kept in tack rooms.
- *Barn Isles are to be kept clear at all times.
- *Horses may never run freely on property
- *Ride only on HHR property, unless on trail outing off HHR property. Do not trespass on neighboring private properties
- *Each horse must have his/her own halter and lead at all times at his/her gate
- *No riding in barn aisles
- *Do not leave horses unattended
- *Do not feed treats to any horses except your own, without permission
- *All feeding of horses under HHR care is done so by HHR staff at scheduled times. No feeding of horses by other at other times is permitted, unless prior arrangements established with management.
- *Use your own equipment
- *All riders and handlers must use tack that allows them to control their horses at all times.
- *While leading horses through barn aisles do not stop to allow your horse to sniff another horse
- *All supplements must be stored in feed room
- *All horses must have the following shots: Strangles, West Nile, Flu Rhino
- *All horses will be wormed on a quarterly basis
- *Tack up in cross ties only
- *Do not leave your horses halter on when you put him/her in his/her stall
- *Please return your horse to the same stall you got him/her out of, do not leave horse in turn out or pasture unless you have asked
- *No handling/riding of non-owned horses (belonging to someone else) without prior consent from owner and prior
